**MINUTES**

*January 21, 2015*

A subcommittee committee meeting of the Constable Ethics, Standards and Training Board (CESTB) was called to order by Constable Scott Tipton at 9:02 a.m. on January 21, 2015. The meeting was held in the Capitol Consulting office located at 818 North First Street, Phoenix AZ 85004. Members participating in the meeting included Constable Tipton. Members participating by teleconference included Constable Nozar and Christine Shipley. Also present was staff Tracy Unmacht and members of the public Jason Brown and Gilbert Zermemo, CBS 5 Investigative Producer.

The following matters were discussed, considered and decided at the meeting:

**Discussion & Possible Recommendation for Open Investigation\***

**CNA126-2014 - Clark:** Constable Tipton outlined the complaint to the members of the board with discussion from all members. Christine Shipley made a motion to request certified copies of Constable Clark's log for the last 12 months. Constable Nozar seconded the motion. The motion carried unanimously.

**CNA128-2014 - Clark:** Constable Tipton outlined the complaint to the members of the board with discussion from all members. Committee agreed there was not enough evidence provided to show an ethical violation. Constable John Nozar made a motion that allegation #4 in the complaint be tabled until such time that evidence is provided to the CESTB showing there is a criminal investigation in the matter. Christine Shipley seconded the motion. Motion carried unanimously. Upon discussion of the other allegations listed in the complaint, Christine Shipley made a motion to table the entire complaint until such time evidence is provided to the CESTB showing there is a criminal investigation in the matter. Constable John Nozar seconded the motion. The motion carried unanimously.

**CNA134-2015 - Clark:** Constable Tipton outlined the complaint to the members of the board with discussion from all members. Christine Shipley made a motion to request a certified copy of the Affidavit of Service for 105-3010 as well as the police report from the traffic accident on July 7, 2014. Constable Nozar seconded the motion. The motion carried unanimously.

**CNA136-2015 - Clark:** Constable Tipton outlined the complaint to the members of the board with discussion from all members. Committee agreed this complaint mirrored elements in the other 3 complaints being reviewed at this meeting. The evidence that will be sought for those complaints may provide information that will help determine any action on this complaint. Christine Shipley made a motion to request a random sample of Constable Clark's log during the 40-month period prior to May 11, 2014. Constable Nozar seconded the motion. Discussion: Christine Shipley wanted clarification on who would be responsible for obtaining the records. Constable Tipton suggested hiring a private investigator and would ask the CESTB for permission to do so. The motion carried unanimously.

**Adjournment**

There being no further business Constable Nozar made the motion to adjourn and Christine Shipley seconded the motion. The motion carried unanimously the subcommittee adjourned at 10:00 a.m.
