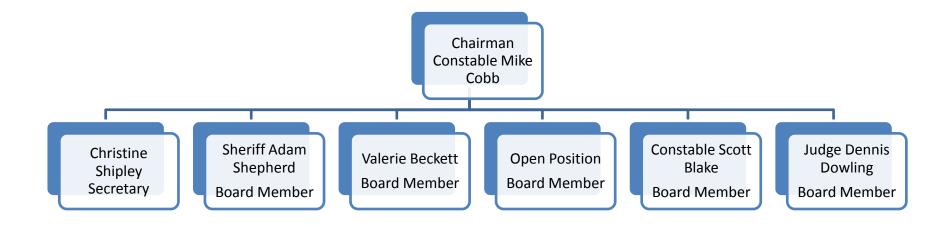

Revenue Forecasting:

The Constable Ethics, Standards & Training Board (Board) receives all of its revenue from writ fees. This fee has remained fairly steady for many years. The number of writs issued has been steady as well, usually growing by a small amount each year, with an occasional decrease from time to time.

In the fall of 2018 a legislative change took affect defining how writ fees would be assessed, to broaden the scope. We saw some increase in revenue toward the end of the year, and predict overall income during FY20 will increase somewhat.

When calculating amounts for our budget this year, we used actual average monthly income through May and projected through June to determine an expected income and adjusted this figure to accommodate for the expected increase in fees collected. The amount represented an overall increase over the previous year.
